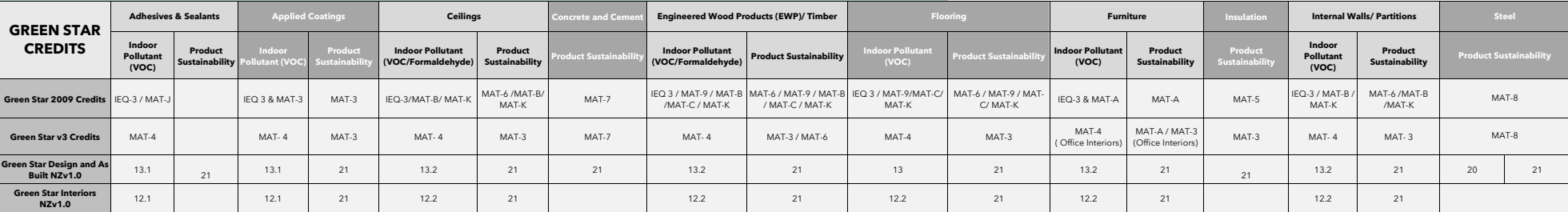


- a. The following table lists recognised ecolabels in Green Star.
- b. Products and Materials for which Eco-labels are an accepted method of compliance are listed across the top row.
- c. Only certificates of final products and materials are recognised in Green Star. Should project teams wish to use a component certificate to demonstrate compliance, a Technical Question needs to be submitted to justify why final product certificates cannot be provided and how component certificates could be used to show that the aim of the credit can be met. Any joinery, cabinetry, shelving or in-built furniture that needs to be assembled on-site can be treated as a final product although they are often perceived to be components. Therefore certificates for these products can be acceptable for compliance.
- d. Certificates from other Indoor Air Quality schemes such as GuT, AgBB and GreenGuard etc may be used to demonstrate compliance if they are referenced as part of the recognised eco-labels listed below.
- e. If a cell is left empty/white, this means there is currently no recognised compliant eco-label for this specification.
